Heirs are also given instruction on building and protecting wealth, the family’s business

and personal values, and on philanthropy and charity donations in accordance with the client’s philosophy,” David says. “We use special trusts to allow purchases while protecting them from divorce, taxation and litigation.”

Cutting-edge technology is also utilized. The firm is experimenting with technology that allows parents and grandparents to leave communications to their children and grandchildren. Those statements are placed on audio and video clips. “This makes our approach to wealth planning, estate planning and asset protection unique,” says Frees.

David Frees is a firm believer in intergenerational family communications. In fact, he wrote the book on the subject, *The Language of Parenting: Building Great Family Relationships At All Ages*. Steve Forbes, Editor-In-Chief of Forbes Magazine. Forbes has called David a “grand master” of family communication.
