# The Estate Planning Basics of Digital Assets: What To Do About Bitcoin, Cryptocurrencies and other Digital Investments - Now OR In The Future | By:

Cryptocurrency (Bitcoin in particular) has only been in existence since 2009 and widespread investment in crypto is very recent. But, it has become much more widespread, and many clients, even older clients, are buying some exposure to this new asset class.

And, like so many new technologies and digital assets, owning cryptocurrency poses challenges when you start to think about protecting it from creditors and for estate planning - passing it on, as part of your wealth and legacy, to a surviving spouse, heirs, or to even to charitable beneficiaries.

Some years ago, I had a very near-death experience.

In particular, I injured my spinal cord at two separate levels and was paralyzed (blessedly only until my surgery a few weeks later). What was most interesting, were the thoughts that went through my mind. I imagined what would happen if I didn't survive the injury and was actually quite comforted that I had quite a lot of life insurance, a well done estate plan (that probably sounds like bragging since I did my own plan), and a clear record of the assets and where they were located (and how to access them).

Cryptocurrencies wouldn't even exist for a few more years so I didn't have to worry about it. But...

...Robin (my wife) and/or the kids would have faced a much more complicated scenario when it came to my estate and getting control over the cryptocurrency investments that I own.

For example, she would, as my Executor, have needed access to the accounts that hold the crypto but would have needed to know where it was held, as well as my private keys and account passwords to get it.

She might also have benefited significantly if I had the foresight to type up detailed instructions on how to access the "coins." But then, where would I store that information that was safe from hacking, and/or real-world prying eyes?

#### So that's the problem...

If anyone dies today, owning cryptocurrency, one of two things would occur:

If they had a will, the digital assets would be distributed to whomever was legally designated to receive them **OR** there would be an intestacy (no will) where state law would say where the assets (including cryptocurrency) would go.



Traditional assets/investments such as real estate or investment/bank accounts are relatively easy to find, access, and delegate with a death certificate and other legal documentation. But crypto poses some unique challenges...

## SUMMER RECIPES | How To Enjoy Burgers That Are Better For You

Eating healthy is something that we all try to do, so we grill our meats and vegetables during the summer (or maybe all year round for hardcore grillmasters). We are social eaters, so we often don't pause to think about how much we are eating. Our good intentions fade with the addition of a pile of cheese and gigantic buns (even the gluten-free ones), and just how big is the burger you're eating?! Here are some suggestions...

Have you thought about eating your burger without the bun? This saves a ton of calories for those of you who like a bigger burger patty. Create a salad bowl meal with your burger on top of the greens. Then add a little sophistication, and great flavor (and less calories) with a garlic aioli topping rather than cheese.

**GARLIC AIOLI:** ½ cup light mayo; 1 clove minced garlic, ½ tsp Dijon mustard, a pinch of salt/pepper to taste; Whisk all ingredients together and drizzle over your burger.

Have you ever tried subbing in ground turkey or chicken for your beef? If you create a plain patty with just the meat, it is not very tasty! However, with the addition of some not so secret ingredients, you can add flavor (and there's less fat/calories). Try this recipe and then get creative with your own.

**BURGER WITH A TWIST:** 1 lb ground chicken or turkey; 1 egg (well beaten); <sup>1</sup>/<sub>4</sub> cup panko breadcrumbs; 2/3 cup shredded sharp cheddar cheese (try light version to cut more calories); <sup>1</sup>/<sub>4</sub> cup green onions; 3 tbsp Dijon mustard; 1 tbsp Worcestershire sauce and a pinch of salt/pepper to taste. | Mix and shape into 4 patties; Grill as usual.
