estate OR you have been appointed by your spouse, parent or other friend or family member, it's best not to wait until you're already doing the job to find out what is actually involved.



**Executor** *(Continued from Page 1)* An executor is the person you appoint under your will whose job it is to conclude your estate (it may also be that you've been appointed under the will of a parent or other person).

Some executors will reduce the cost to the estate by personally performing many of these tasks and specific checklist items. However, in a busy world where the demands of work and family life are already stressful and tiring, and because many of the tasks are highly technical (like preparing and filing the lifetime tax returns and the death tax returns and all of the elections within each return), many executors seek the advice of a professional team (like lawyers, accountants, and investment advisers).

#### How to Protect Yourself from Social Security Scams |

You receive an unexpected phone call, text, or email from someone claiming to be from the SSA who needs to speak with you urgently. There is a problem with your Social Security number, they warn that it's been linked to criminal activity and suspended! Or they explain that to qualify for an increase in your benefit, you must register and pay a fee to obtain it. To address whatever issue they present, you need to share your Social Security number, other sensitive information, or pay money.



Remember that the SSA will not call you out of the blue and ask for your Social Security number, they already have it. Don't engage with anyone claiming to be from the SSA; if you are concerned there is a problem with your account, contact SSA at 800-772-1213 (but prepare to wait a while before you talk to a person). You can set up a "My SSA Account" and receive encrypted communications from

SSA. With this access, you can go online to find if SSA is trying to reach you, or check the status of an application, get a replacement card, and more. Get started at <u>ssa.gov/myaccount</u>. If you shared your Social Security number and feel it was part of a scam, file a police report for a record, and go to <u>IDtheft.gov</u> for specific guidance on protecting against its use in identify fraud.

#### SPRING COCKTAIL RECIPES |

Lavender Lemon Drop (makes 1 drink) (<u>https://emilyfabulous.com/</u>) Ingredients: 2 oz vodka; 1 oz freshly squeezed lemon juice; 1 oz <u>lavender syrup</u> (\* recipe:

https://emilyfabulous.com/lavender-simple-syrup-recipe/) **Directions:** Important to chill your cocktail glass! Place all the ingredients into a cocktail shaker with fresh ice. Shake until nice and cold, about 10 seconds. Strain into a chilled cocktail glass. Garnish with a fresh lavender spring or a lemon peel.





**Raspberry Lemon Cocktail** (or Mocktail) (<u>https://marisamoore.com/</u>) Makes 4 (8 oz) drinks **Ingredients:** 1 pint fresh or frozen raspberries; 2 lemons; 2 tbsp sugar; 4 oz vodka; Ice; 16 oz lemon sparkling water; Raspberries and lemon slices for garnish **Directions:** Muddle <sup>3</sup>/<sub>4</sub> of the raspberries with the sugar and lemon juice until the berries are crushed in a large wide mouth jar. Add the vodka (or sub sparkling water for mocktail). Add a handful of ice cubes to the jar. Close the lid and shake vigorously. Using a strainer, pour about 4 ounces of the raspberry lemon vodka mixture into each of the smooth-sided jars. Top each with 4 ounces of sparkling water. Garnish with raspberries and lemons. Serve immediately.
